AN ACT of the County Assembly of Elgeyo/Marakwet to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the Financial Year ending on the 30th June, 2016, and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Elgeyo/Marakwet as follows—

1. This Act may be cited as the Elgeyo/Marakwet County Appropriation Act, 2015. Short title.

2. The County Treasury may issue the sum of Three Billion, Six Hundred and Sixty Five Million, Four Hundred and Forty Nine Thousand, One Hundred and Sixty Five Shillings only, out of the County Revenue Fund and apply it towards the supply granted for the service of the Financial Year ending on the 30th June, 2016 Issue of KSh.
3,665,449,165 out
of the Consolidated
Fund for the service
of the year ending
30th June, 2016.

3. KSh. 3,665,449,165, the sum specified in the third column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of revenue directed to be applied outside the County Revenue Fund under Article 207 (1) of the Constitution. Appropriation of the
Money granted.

4. The supply granted for the services of the year ending on the 30th June, 2016, in respect of Votes R.305-01, R.305-02, R.305-03, R.305-04, R.305-05, R.305-06, R.305-07, R.305-08, R.305-09, R.305-10, R.305-11, R.305-12, R.305-13, D.305-01, D.305-02, D.305-03, D.305-04, D.305-05, D.305-06, D.305-07, D.305-08, D.305-09, D.305-10, D.305-11, D.305-12, D.305-13 in accordance with the Elgeyo/Marakwet County Appropriation Act, 2015.
