**THE ELGEYO/MARAKWET COUNTY FINANCE
ACT, 2015**

**AN ACT of the County Assembly of Elgeyo/Marakwet
to provide for the revenue raising measures of the
County Government of Elgeyo/Marakwet for the
year 2015/2016 and for connected purposes**

ENACTED by the County Assembly of Elgeyo/Marakwet,
as follows—

PART I—PRELIMINARY

1. (1) This Act may be cited as the Elgeyo/Marakwet County Finance Act, 2015 and shall, subject to section 2 (2), come into operation on such a date as the County Executive Committee Member for Finance may appoint and different dates may be appointed for different provisions.

Short title and
commencement.

(2) The respective taxes, fees and charges, together with the rates applicable shall take effect in not later than three months after the commencement of this Act.

2. (1) The taxes, fees and charges set out in the Schedule shall apply for the respective services and at the rates set out therein.

Interpretation.

(2) For greater certainty, the taxes, fees and charges applicable at the commencement of this Act shall continue to apply under the existing by-laws of the defunct Councils of Elgeyo/Marakwet until such by-laws are repealed and replaced by county legislation.

(3) For purposes of Iten Township, the rates, fees and charges payable under section 2 shall be applicable to all business being operated within a radius of three (3) kilometers from the central business district.

**PART II—FEES AND TAXES PAYABLE AND
RATES APPLICABLE**

3. The revenue raising measures of the county government relating to property rates are set out in the Schedules.

Property Rates.

4. The revenue raising measures of the county government relating to fees and charges for services are set out in the Schedule.

Other Fees and
Charges for
Services.

5. The revenue raising measures of the county government provided for by the Act do not in any way prejudice national economic policies, economic activities across county boundaries or the national mobility of goods, services, capital or labour.

No prejudice to charges for services.

6. Persons with Disabilities in possession of a certificate of disability, shall pay Forty percent (40%) of the respective taxes, fees and charges as provided for in this Act.

Persons with disabilities.

PART III—PAYMENT

7. (1) Any payment to the County shall be made to an officer appointed by the County to collect revenue or through any other mode of payment as may be prescribed by the County Executive Committee Member.

Payment to the County.

(2) An officer appointed by the County to collect revenue shall have identification card issued by the County which shall be pinned or tagged where it can be easily identified by any person.

(3) A County official receipt shall be issued for all payments made to the County.

(4) A person shall not receive or collect any money on behalf of the County unless he or she has been appointed to do so or has authority as the receiver and collector of the County revenue.

(5) A person who contravenes the provisions of this section commits an offence.

PART IV—OFFENCES AND PENALTIES

8. (1) Any person who commits an offence under this Act for which no penalty is provided shall be liable, on conviction, to a fine not exceeding two hundred thousand shillings or to imprisonment for a term not exceeding one year or both.

General Penalty.

(2) To maximise revenue collection, use of other arms of the National Government shall be applied during enforcement.

(3) Any impounded item not claimed shall be auctioned after three months from the date of impoundment unless otherwise specified.

9. A member of staff of the County or any other person having duty to perform under this Act who—

Offences by Staff of
the County.

- (a) makes, in any record, or document required to be kept or made by that person, an entry which he or she knows or has reasonable cause to believe not to be true or to be false; or
- (b) wilfully refuses to do anything which he or she knows or has reasonable cause to know is required to be done; or
- (c) interferes with any other person or process under this Act, so as to defeat the provisions or requirements of this Act; or
- (d) where required under this Act to do anything to give effect to the provisions of this Act, fails to do that thing; or
- (e) without reasonable cause omits to do something in breach of his or her duty under this Act; or
- (f) wilfully contravenes the provision of this Act to give undue advantage or favour to another person; or
- (g) fails to prevent or report to the County or any other relevant authority, the commission of an offence committed under this Act;

Commits an offence and is liable on conviction, to a fine not exceeding two hundred thousand shillings or to imprisonment for a term not exceeding one year, or both.

PART V—AMENDMENTS TO THE SCHEDULE

10. (1) The Executive Committee Member responsible for finance may forward to the County Assembly a legislation proposal entailing amendments of the schedules for considerations.

Amendments to the
Schedule.

(2) Any proposed legislation made under subsection (1) shall be laid before the County Assembly without unreasonable delay, and unless a resolution approving the proposed legislation is passed by the County Assembly within twenty one days when the Assembly next sits after the proposed legislation is so laid, the proposed legislation shall lapse.

PART VI—MISCELLANEOUS

11. If any national Act mentioned in the Schedule has not been amended to provide for the imposition of the fees or charges for services by the county government, then paragraph 7 of the Sixth Schedule of the Constitution applies in relation to that Act.

Application of
Transitional

12. For avoidance of doubt, nothing in this Act is to be taken to prevent a county government from entering into a contract or agreement or other arrangement to provide a service upon payment of a fee or charge.
