**AN ACT of the County Assembly of Elgeyo/Marakwet
to amend Elgeyo/Marakwet County Revolving
Fund Act, 2014**

ENACTED by the County Assembly of
Elgeyo/Marakwet as follows—

1. This Act may be cited as the Elgeyo/Marakwet
County Revolving Fund (Amendment) Act, 2016.

Short title.

2. The long Title of the Elgeyo/Marakwet County
Revolving Fund Act, 2014, in this Act referred to as the
“principal Act” is amended by inserting the words “ the
staff and the speaker” immediately after the word
“members of the County Assembly”.

3. Section 2 of the “principal Act” is amended by—

(a) deleting the definition of “member of the
scheme” and substituting with the following;

“Members of the Scheme” means members of the
County Assembly, the staff and the speaker;

(b) inserting the following definition in its proper
alphabetical sequence – “staff” means the staff of
the County assembly.

deleting the word “Assembly” and substituting the word
“scheme”.

inserting the following new paragraph “g” immediately
after paragraph “f”

(d) (e) (f) (g) and (h) respectively.

7. Section 13 (3) of the Principal Act is amended by deleting the words “at least ninety days before the expiry of the term of the member of the County Assembly” and substituting the words “on such terms and conditions as the Salaries and Remuneration Commission shall provide”.

8. Section 18 of the Principal Act is amended by deleting the words “three million Kenya Shillings” and substituting the words “based on such ceiling as the Salaries and Remuneration Commission shall determine from time to time”.
