**THE ELGEYO MARAKWET COUNTY
REVOLVING FUND (AMENDMENT) BILL, 2015**

A Bill for

**AN ACT of the County Assembly of
Elgeyo/Marakwet to amend the
Elgeyo/Marakwet/County Revolving Fund Bill, 2014**

ENACTED by the County Assembly of
Elgeyo/Marakwet as follows—

1. This Act may be cited as the Short title.
Elgeyo/Marakwet/County Assembly Revolving Fund
(Amendment) Act, 2015.

2. The long Title of the Elgeyo/Marakwet County Amendment of
the long Title of
Act No. 4 of
2014.
Revolving Fund Act, 2014, in this Act referred to as the
“principal Act” is amended by inserting the words ” and the
staff” immediately after the word “members of the County
Assembly”.

3. Section 2 of the “principal Act” is amended by— Amendment of
section 2 of Act
No. 4 of 2014.
(a) deleting the definition of “member of the scheme”
and substituting with the following;

“members of the scheme” means members of the
County Assembly and the staff;”

(b) inserting the following definition in its proper
alphabetical sequence-“staff” means the staff of
the County Assembly.

4. Section 4 of the Principal Act is amended by Amendment of
section 4 of Act
No. 4 of 2014
deleting the word “Assembly” and substituting the word
“scheme.”

5. Section 6 of the Principal Act is amended by Amendment of
section 6 of Act
No. 4 of 2014.
amending the section and creating subsections as follows
—

(1) There is established two committees to be known
as the Loans Management Committee, for the Members of
the County Assembly and the staff.

(2) The Loans Management Committee for the
Members of the County Assembly shall consist of—

(here retain the memberships as contained in the principal
Act).

(3) The Loans Management Committee for the staff shall consists of—

- (a) the Clerk of the County Assembly who shall be the Chairperson;
- (b) the deputy clerks of the County Assembly;
- (c) the principal finance officer of the County Assembly;
- (d) the officer-in-charge of internal audit in the County Assembly;
- (e) The officer-in-charge of Budget in the County Assembly; and
- (f) an officer-in-charge of staff welfare.

Section 7 of the principal Act be amended by inserting the word “each” immediately after the word “functions.”

6. Section 8 (3) of the Principal Act is amended by deleting the word ‘The’ at the beginning of the section and substituting with the words “Each of the.” Amendment of section 8 of Act No. 4 of 2014.

Section 8 (3) of the Principal Act is amended by deleting the words “three other Members of the committee” and substituting the words “half of the other Members.”

7. Section 13 (3) of the Principal Act is amended by deleting the words “at least ninety days before the expiry of the term of the member of the County Assembly” and substituting the words “on such terms and conditions as the Salaries and Remuneration Commission shall provide.” Amendment of section 13 of Act No. 4 of 2014.

8. Section 16 (3) of the Principal Act is amended by deleting the words “three million Kenya Shillings” and substituting the words “based on such ceiling as the Salaries and Remuneration Commission shall determine from time to time.” Amendment of section 16 of Act No. 4 of 2014.

9. Section 23 of the Principal Act is amended by deleting the words “the maximum amount of two million shillings or.” Amendment of section 23 of Act No. 4 of 2014.

10. Section 28 of the Principal Act is amended by — Amendment of section 28 of Act No. 4 of 2014.

- (a) Inserting the words “if any,” immediately after the words “gratuity dues;” and
- (b) Inserting the words “or the services of the Member

is terminated,” immediately after the words
“County Assembly seat.”

11. Section 30 of the Principal Act is amended by inserting the words “of the scheme,” immediately after the words “relevant member.”
