AN ACT of the County Assembly of Embu to authorize the issue of a sum of money out of the County Revenue Fund and its application to the service of the year ending 30th June, 2019, and to appropriate that sum for certain public services and purposes

ENACTED by the County Assembly of Embu, as follows—

1 This Act may be cited as the Embu County Supplementary Appropriation (No 2) Act, 2019

Short title

2 The County Treasury may issue out of the County Revenue Fund the sum of Kenya Shillings **Six Billion, Eight Twenty Seven Million, Two Hundred and Thirty Nine Thousand, Three Hundred and Eighty Six** for the service of the various outstanding services and purposes specified in the Schedule in respect of the year ending on the 30th June, 2019
