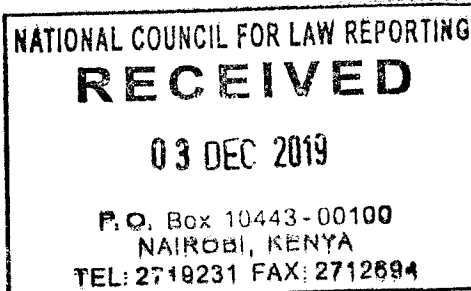

**THE KERICHO COUNTY SUPPLEMENTARY
APPROPRIATION (NO. 2) ACT, 2018**

No. 2 of 2019

Date of Assent: 30th May, 2019

Date of Commencement: 4th June, 2019

AN ACT of County Assembly to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2019 and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Kericho, as follows—

1. This Act may be cited as the Kericho County Supplementary Appropriation (No. 2) Act, 2019.

2. The treasury may issue out of the consolidated fund and apply towards the supply granted for the service of the year ending on the 30th June, 2019 the sum of Kenya Shillings **Eight Billion, Four Hundred and Seventeen Million, Nine Hundred and Sixty-Seven Thousand, Two Hundred and Seventy-Three** and that sum shall be deemed to have been appropriated as from 1st July, 2018 for the services and purposes specified in the schedule.
