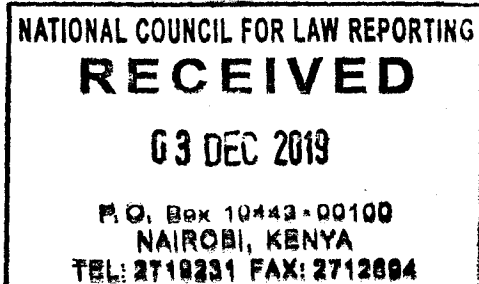

**THE KERICHO COUNTY SUPPLEMENTARY
APPROPRIATION BILL (No. 2), 2018**

A Bill for

AN ACT of the County Assembly of Kericho to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2018 and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Kericho as follows—

1. This Act may be cited as the Kericho County ^{Citation.} Appropriation Act, 2018.

2. The treasury may issue out of the consolidated fund and apply towards the supply granted for the service of the year on the 30th June, 2018 the sum of Kenya shillings Six billion, five forty eight million, one hundred and thirty six thousand, zero nineteen that sum shall be deemed to have been appropriated as from 1st July 2017 for the services and purposes specified in the schedule.
