A Bill for

AN ACT of the County Assembly of Kericho to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2015 and to appropriate that sum by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Kericho County, as follows—

Short title

1. This Act may be cited as the Supplementary Appropriation Act, 2015.
2. The treasury may issue out of the consolidated fund and apply towards the supply granted for the service of the year on the 30th June, 2015, the sum of Kenya shillings Four billion, nine seventy four million, Six Hundred and Ninety Three Thousand, Six Hundred and Sixty Nine that sum shall be deemed to have been appropriated as from 1st July, 2014 for the services and purposes specified in the schedule.
