**THE KERICHO COUNTY SUPPLEMENTARY
APPROPRIATION BILL, 2017**

A Bill for

AN ACT of the County Assembly to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2017 and to appropriate those sums for certain public services and purposes

ENACTED by the Kericho County Assembly as follows—

1. This Act may be cited as the Kericho County ^{Citation.} Supplementary Appropriation Act, 2017.

2. The treasury may issue out of the consolidated fund and apply towards the supply granted for the service of the year on the 30th June, 2017 the sum of Kenya shillings Six billion, Two eighty five million, Seventy Nine thousand Four hundred and twelve, that sum shall be deemed to have been appropriated as from 1st July, 2016 for the services and purposes specified in the schedule.

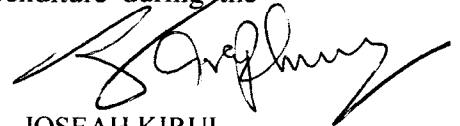
