AN ACT of the County Assembly of Kiambu to amend
the Kiambu County Education Bursary Fund Act,
2014

ENACTED by the County Assembly of Kiambu, as follows—

1. This Act may be cited as the Kiambu County Education Bursary Fund (Amendment) (No. 2) Act, 2018. Short title
2. Section 5 (4) of the Kiambu County Education Bursary Fund Act, 2014, in this Act referred to as “ the Principal Act” is amended by— Amendment of
Section 5 of No.10
of 2014
 - (a) Deleting the word “nine” appearing immediately after the words “amount totaling” and replacing it therefor with the word “twelve”.
 - (b) By deleting subsection (5).

MEMORANDUM OF OBJECTS AND REASONS

The Principal object of this Bill is to amend the Kiambu Education Bursary Fund Act, 2014 in order to bring it into conformity with the Public Finance Management (County Government) regulations, 2015.

Clause 2 seeks to amend section 5 to include the contents of subsection 5 (5) as part of the administration fees and increase the amount available for disbursement under subsection 5 (4).

Section 5 of the Kiambu County Education Bursary Fund Act, 2014 which it is proposed to amend—

Section 5—Uses of the Fund

- (1) The Fund shall be used for—
 - (a) providing education grants or bursaries to eligible students enrolled in secondary schools universities and colleges and special primary or secondary schools;
 - (b) granting scholarships in accordance with the criteria established under this Act; and
 - (c) meeting any expenditure related to administration of the Fund as may be approved by the Executive Member.
- (2) The administration expenses shall not be more than three percent of the total monies in the Fund.
- (3) An amount totaling to eighty five per cent of the monies set aside for disbursement under this Act shall be allocated equally to all the Wards in accordance with the criteria set out in the Regulations.
- (4) An amount totaling nine per cent of the monies set aside for disbursement under this Act shall be utilized for special categories in accordance with the formula set out in the Regulations.
- (5) An amount totaling to three percent of the monies in the Fund shall be utilized for monitoring and evaluation, training, sensitization on the Fund and facilitation of the activities of the mentorship programme.
