**THE MAKUENI COUNTY APPROPRIATION
BILL, 2016**

A Bill for

AN ACT of the County Assembly of Makueni to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2017, and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Makueni, as follows—

1. This Act may be cited as the Makueni County ^{Short title.} Appropriation Act, 2016.

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2017, the sum of Kenya Shillings **Seven billion, Two Hundred and Fifty One Million, Two hundred and Seventy Eight thousand, Eight hundred and Sixty Two Only** (7,251,278,862.00), and that sum shall be deemed to have been appropriated for the services and purposes specified in the Schedule. The department of Health Budget is inclusive of KSh. 95,744,681.00 for Conditional Allocation for Leasing of Medical Equipment, KSh. 19,449,802.00 for Conditional Allocations for compensation for User Fees Forgone, Kshs 83,696,467.00 for Conditional Allocations for Free Maternal Health Care Allocation, appropriated under development budget. The department of Transport Budget is inclusive of KSh. 98,971,324.00 for Conditional Allocation from Road Maintenance Fuel Levy Fund, appropriated under development budget. The department of Finance Budget is inclusive of KSh. 12,065,000.00 for Conditional Allocation other loans and grants appropriated under development budget.

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the schedule in the amounts specified in the third column of the schedule.
