AN ACT of the County Assembly of Mandera to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending 30th June, 2020 and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Mandera, as follows—

Short title

1. This Act may be cited as Mandera County Supplementary Appropriation (No. 3) Act, 2020.

Issue of KSh. 13,118,313,035 out of the County Revenue Fund for the service of the year ending 30th June, 2020

2. The County Treasury may issue the sum of **Kenya Shillings Thirteen Billion, one hundred and eighteen million, three hundred thirteen thousands and thirty five only** out of the County Revenue Account and apply towards the supply granted for the service of the year ending on the 30th June, 2020.

Appropriation of the Money granted

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that schedule.

Appropriation in aid

4. In addition to the sum granted by section 2, the sum specified in the fourth column of the first and second schedules shall be applied for the several services and purposes specified in second column of those schedules, out of revenue directed to be applied outside the County Revenue Fund as per article 207 (i) of the Constitution.

5. The supply granted for the services of the year ending on 30th June, 2020, in respect of votes R341-01, R341-02, R341-03, R341-04, R341-05, R341-06, R341-07, R341-08, R341-09, R341-010, R341-11, R341-12, R341-13, D341-01, D341-02, D341-03, D341-04, D341-05, D341-06, D341-07, D341-08, D341-09, D341-10, D341-11, D341-12 in accordance with the Supplementary Appropriation (No. 3) Act, 2020.
