**THE NYANDARUA COUNTY BURSARY FUND (AMENDMENT)
ACT, 2015**

No. 3 of 2015

Date of Assent: 26th June, 2015

Date of Commencement: 26th June, 2015

Short Title

1. This Act shall be cited as the Nyandarua County Bursary Fund (Amendment) Act, 2015 and shall come into operation on publication.

Amendment of Section 4 (2) of No. 3 of 2014

2. Section 4 (2) of the principal Act is amended by deleting the words "Executive Committee Member or by a person appointed by him or her with the concurrence of the County Executive Committee member of finance and with the approval of the Assembly" and by inserting in place the words "an Administrator designated by the County Executive Member for finance in accordance section 116 of the Public Finance Management Act, 2012.

Amendment of Section 5 (2) of No. 3 of 2014

3. The principal Act is amended by wholly deleting Section 5 (2) (a) and (e).

Amendment of Section 6 of No. 3 of 2014

4. The principal Act is amended by wholly deleting Section 6 and in place inserting the words:-

5. (a) The Members of the Committee under Section 5 (2) (c-f) shall have the following qualifications—

- (i) have attained at least Kenya Certificate Secondary Education or its equivalent;
- (ii) meet the requirements of Chapter Six of the Constitution; and
- (iii) a resident of the Ward.

(b) The Members of the Committee under Section 5 (2) (c-f) shall be competitively recruited by the County Public Service Board taking into consideration the values and principles of public service as enshrined under Article 232 of the Constitution;

(c) The remuneration of the Committee Members shall be subject to recommendation by the Salaries and Remuneration Commission.

6. The principal Act is amended by wholly deleting Section 8 (3).

Amendment of Section 17 of No. 3 of 2014

7. Section 17 of the principal Act is amended by inserting the words "for finance" immediately the words "Executive Committee member."

Insertion of new Section 17 A into No. 3 of 2014

8. The principal Act is amended by inserting the following new section—

17A. (a) The Fund shall be audited in accordance with the Public Audit Act Cap 412A and Section 155 of the Public Finance Management Act No. 18 of 2012.

9. The principal Act is amended by wholly deleting paragraph 4 of the first schedule and inserting thereon the following new schedule:

Special Schools	5,000
Boarding Primary Schools	5,000
Day Secondary Schools	3,000
Boarding Secondary Schools	6,000
Youth Polytechnics	3,000
Tertiary Institutions (Colleges, Universities)	10,000
