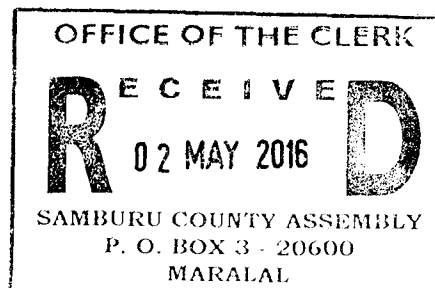

**THE SAMBURU COUNTY BURSARIES FUND
(AMENDMENT) ACT, 2016**

**AN ACT of the County Assembly of Samburu to amend
the Samburu County Bursaries Fund Act; and for
connected purposes**

ENACTED by the County Assembly of Samburu, as
follows—

1. This Act may be cited as the Samburu County
Bursaries Fund (Amendment) Act, 2016.

Short title

2. Section 2 of the Samburu County Bursaries Fund
Act, in this Act referred to as the “principal Act” is
amended by inserting the following new definition
immediately after the definition of the term “beneficiary”—

“bursary co-ordinator” means the officer appointed
under Section 5 to administer the fund;

3. The principal Act is amended by inserting the
following new section immediately after section 3—

Application

3A. This Act shall apply within the jurisdiction of
Samburu County.

4. Section 4 of the principal Act is amended by
inserting the following new subsection immediately after
subsection (3)(a) —

(aa) providing bursary to college and university
students.

5. Section 12 (2) (d) of the principal Act is amended
by deleting the expression “from the office of the elected
Ward Representative” appearing immediately after the
words “a representative” and substituting therefore with the
expression “of non-governmental organization in the
ward”.
