

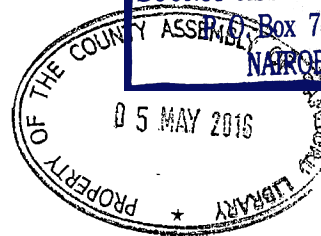

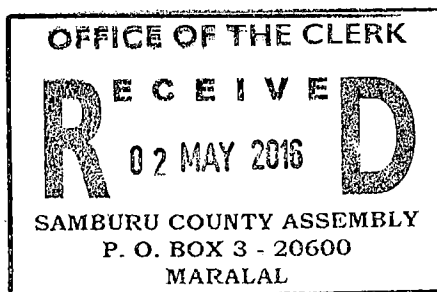

**THE SAMBURU COUNTY SUPPLEMENTARY
APPROPRIATION ACT, 2016**

No. 2 of 2016

Date of Assent: 23rd April, 2016

Date of Commencement: 28th April, 2016

AN ACT of the County Assembly of Samburu to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2016 and to appropriate that sum by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Samburu, as follows—

1. This Act may be cited as the Samburu County Supplementary Appropriation Act, 2016.

Short title

2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2016, the sum of Kenya Shilling Four Billion Four Hundred Forty Eight Million Nine Hundred and Eight Thousand Two Hundred and Ninety Two only, and that sum shall be deemed to have been appropriated as from the 1st July, 2015 for the services and purposes specified in the Schedule.

3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.

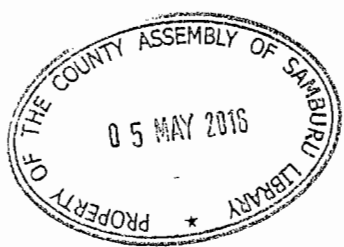
