**THE SAMBURU COUNTY SUPPLEMENTARY APPROPRIATION
ACT, 2019**

No. 4 of 2019

Date of Assent: 18th October 2019

Date of Commencement: 22nd October, 2019

AN ACT of the County Assembly of Samburu to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2020 and to appropriate that sum by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Samburu, as follows—

Short title

1. This Act may be cited as the Samburu County Supplementary Appropriation Act, 2019.

Issue of KSh. 6,802,165,441.00 out of the County Revenue Fund for service of the year ending 30th June, 2020 and appropriation of the money granted

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2019, the sum of **Kenya shillings Six billion, Eight hundred and Two million, One hundred and Sixty Five Thousand, Four hundred and Forty One only**, and that sum shall be deemed to have been appropriated as from the 1st July, 2019 for the services and purposes specified in the Schedule.

Appropriations in Aid

3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.

Appropriation of the money granted

4. The supply granted for the services of the year ending on 30th June 2020, in respect of Votes in accordance with the Supplementary Appropriation Bill, 2019.
