**THE KWALE COUNTY SUPPLEMENTARY
APPROPRIATION ACT, 2016**

No. 5 of 2016

Date of Assent: 9th June, 2016

Date of Commencement: 13th June, 2016

AN ACT of the County Assembly of Kwale to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2016 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Kwale as follows—

1. This Act may be cited as the Kwale County Short title.
Supplementary Appropriation Act, 2016.

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2016, the sum of Kenya Shilling **Seven Billion, Six hundred and Eleven million, Four hundred Seventy Seven thousand Four hundred thirty nine cents ninety eight only.**

3. The sum granted by section 2 shall be appropriated for the several services and purpose specified in the second column of the schedule in the amounts specified in the third column of the schedule.

4. The sum granted out of the County Revenue Fund by section (2) includes the sum of Kenya Shilling Seven Billion, Six hundred and Eleven million, Four hundred Seventy Seven thousand Four hundred thirty nine cents ninety eight only.

5. Authorized by the County Assembly on the 7th June, 2016, in accordance with Article 224 of the Constitution, 2010.

6. The supply granted for the services of the year ending on 30th June 2016 in respect of votes 3061, 3062, 3063, 3064, 3065, 3066, 3067, 3068, 3069, 3070, 3071, 3072 and 3073 in accordance with the Supplementary Appropriations Bill, 2016.
