ADMINISTRATION (AMENDMENT) ACT, 2018**

AN ACT of the County Assembly of Tana River to amend the Tana River County Ward Bursary Fund Administration Act, 2014 and for connected purposes.

ENACTED by the County Assembly of Tana River, as follows—

Short title and commencement

1. This Act may be cited as the Tana River County Ward Bursary Fund Administration (Amendment) Act, 2018 and shall come into force on the fourteenth day after its publication in the *Gazette*.

Amendment to Section 5 of Act (No. 2 of 2014)

2. The Tana River County Ward Bursary Fund Administration Act, 2014 (hereinafter referred to as the “Principal Act”) is amended—

- (a) in Section 5 by—
 - (i) deleting subsection (3);
 - (ii) deleting subsection (6);
- (b) in Section (5) subsection (7) by—
 - (i) inserting the word “Three” at the beginning of subsection (7);
 - (ii) deleting the words “for finance and planning” immediately after the words “county executive committee” and substituting therefor the words “member for education”
- (c) in Section (5) subsection (8) by—
 - (i) deleting the words “Executive Committee Member for Finance and Planning” immediately after the words “either gender appointed by the” and substituting therefor with the words “County Executive Committee member for education”;
 - (ii) deleting the words “Two heads of schools from either gender” appearing at the beginning of subsection (8) and substituting therefor with the words “One head of school”.

- (d) in Section (5) subsection (9) by —
- (i) inserting the words “from persons living” immediately after the words “one member”
 - (ii) inserting the words “nominated by the registered umbrella organisation of persons living with disabilities in the county, and” immediately after the words “with disability”
 - (iii) deleting the words “Executive Committee Member for Finance and Planning” immediately after the words “appointed by the” and substituting therefor with the words “County Executive Committee member for gender, culture and social services,”.

Amendment to Section 8 of Act (No. 2 of 2014)

3. Section 8 of the Principal Act is amended by deleting subsection (3).

Amendment to Section 13 of Act (No. 2 of 2014)

4. Section 13 of the Principal Act is amended by —

(1) deleting subsection (1) and substituting therefor the following new subsection —

13. (1) There shall be established a Ward Bursary Committee in respect of each ward.

(2) inserting the following new subsection (1A) immediately after subsection (1) and renumbering the subsequent subsections —

(1A) A committee established under subsection (1) shall consist of —

- (a) one person representing education institutions;
- (b) two persons, a male and a female, representing the youth;
- (c) one person representing persons living with disabilities; and
- (d) one person necessary to ensure that not more than two-thirds of the membership of a Committee are of the same gender.

Insertion of new section 13A

5. The Principal Act is amended by inserting the following new section 13A immediately after section 13 and renumbering the subsequent sections.

Term of Office and Meetings of a Committee

13A. (1) A member of a Committee shall serve for a term of five years.

(2) A Committee shall meet not more than twelve times in every financial year.

Insertion of new section 23A

6. The Principal Act is amended by inserting the following new section immediately after section 23.

23A Regulations

(1) The County Executive Committee member responsible for matters of education shall, in consultation with the Board and the Committees, make regulations generally for the better carrying out of the objects of this Act.

(2) Without prejudice to the generality of subsection (1), the regulations may prescribe—

- (a) scope and procedures of administration of the Bursary applications;
- (b) the additional guidelines regarding bursary awards; and
- (c) the application forms.

Amendment of the First Schedule of Act (No. 2 of 2014)

7. The Principal Act is amended in the First Schedule by deleting paragraph (4) and renumbering the subsequent paragraphs.
