THE THARAKA NITHI COUNTY APPROPRIATION ACT, 2017

No. 2 of 2017

Date of Assent: 7th July, 2017

Date of Commencement: 10th July, 2017

AN ACT of the County Assembly of Tharaka Nithi to authorise the issue of sum of money out of the Consolidated Fund and its application towards the service of the year ending on the 30th June, 2018 and to appropriate the sum and the sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Tharaka Nithi, as follows—

Short title

1. This Act may be cited as the Tharaka Nithi County Appropriation Act, 2017.

Issue of KSh. 4,506,135,122 out of the County Revenue Fund for the service of the year ending 30th June, 2018 and appropriation of the money granted.

2. The County Treasury may issue out the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2018, the sum of Four Billion, Five Hundred and Six Million, One Hundred and Thirty-Five Thousand, One Hundred and Twenty-Two shilling, and that sum shall be deemed to have been appropriated as from 1st July, 2017, for the services and purposes specified in the schedule.
