THE VIHIGA COUNTY APPROPRIATION ACT

No. 1 of 2013

Date of Assent: 27th June, 2013

Date of Commencement: 1st July, 2013

An Act of the County Assembly to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2013 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Vihiga, as follows—

1. This Act may be cited as the Appropriation Act, 2013.

Short title.

2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2013, the sum of Kenya Shillings three hundred and sixty million, six hundred and eight three thousand, one hundred, and that sum shall be deemed to have been appropriated as from 1st March 2013, for the services and purposes specified in the Schedule.

3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as appropriations-in-aid under section 13(2A) of the Government Financial Management Act, 2004 No. 5 of 2004.
