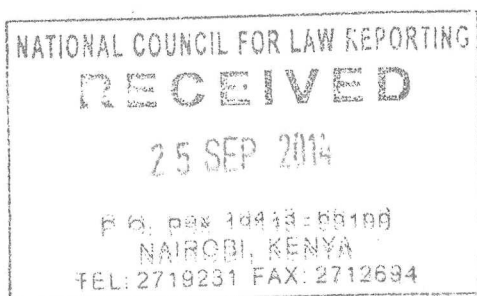

**An Act of the County Assembly of Trans Nzoia
to provide for payment of 2013/2014 County
Government outstanding debts out of unspent
monies for the 2013/2014 financial year and
for certain County Government services and
purposes**

ENACTED by the County Assembly of Trans
Nzoia as follows—

1. This Act may be cited as The Trans Nzoia
County Supplementary Appropriation Act, 2014.

Short title

2. The County Government of Trans Nzoia may
pay out of monies not appropriated and/or not yet spent
as at the end of the 2013/2014 financial all and/or any
outstanding debts and pay for such services and purposes
as at that date as provided for in schedule one.
