A Bill for

**AN ACT of the County Assembly of Trans Nzoia to amend the Trans
Nzoia County Youth And Women Development Fund Act, No. 2
of 2014**

ENACTED by County Assembly of Trans Nzoia as follows—

Short Title

1. This Act shall be cited as the Trans Nzoia County Youth and Women Development Fund (Amendment) Act, 2016.

Amendment of Arrangement of sections

2. The Trans Nzoia County Youth and Women Development Fund Act, Act No. 2 of 2014, hereinafter referred to as the “Principal” Act.

(a) **Delete** the entire sequence of arrangement of Sections from sections 17 to 35, both sections inclusive and **replace with the following sequence;**

17— Youth and Women Ward Committee

18—The Functions of the Youth and women ward Fund Committee

19—Removal from office

20— Vacation of office

21— Filling of vacancy

22— Special ward Committee

23— Disbanding of the special Committees

24— Delegation by the Board

25— Official seal of the Fund

26— Signing o behalf of the Board

27— Protection of Members of the Fund and staff from liability

28— Administration of the Fund

29— Conditions for grant of loan

PART III—FINANCIAL PROVISIONS

30— Annual estimates

31— accounts and Audit

32— Annual report and publication

33— Financial Year of the Fund

PART IV—MISCELLANEOUS PROVISIONS

34— Disclosure of interest

35— Regulations

3. Amendment of Section 8 of Act No. 2 of 2014 of the “Principal Act.

- (a) In Sub-section 8 (1)(b) delete “Ministry of” and replace with “department responsible for”
- (b) In Sub-section 8 (1) (c) delete “Ministry” and replace with “department” and add the word “finance” and “responsible for”.
- (c) delete Sub-section 8 (1) (f)
- (c) In Sub-section 8 (1) (g) delete the entire text and replace with “The Chief Officer for the department responsible for youth and women affairs, who shall be the Secretary to the Board”.
- (d) In Sub-section 8 (1) (h) insert the words “a resident of the county” between the words “disability” and “nominated” and introduce the word “council” with “the National Council For Persons With Disabilities established under the Persons With Disabilities Act, No. 14 of 2003”

4. Amendment of Section 16 of Act No. 2 of 2014

- (a) In sub-section 16 (1) delete the words “ministry of” and replace with “department responsible for”.

5. Amendment of Section 17 of Act No. 2 of 2014

- (a) In Sub-section 17(2) (a) replace “CEO of” with “secretary to”.
- (b) In Sub-section 17 (2) (b) replace “woman” after “the” with “women in the ward”
- (c) In sub- section 17 (2)(c) add the words “in the ward” after “youths”
- (d) In Sub-section 17 (2) (d) delete the entire text.
- (e) In Sub-section 17 (2) (e) delete and replace the entire text with “One Person elected from among the active religious groups in the Ward.
- (f) In Sub-section 17 (2) (f) delete and replace the entire text with “one person representing persons with disability in the ward.
- (g) In sub-section 17 (2) (g) delete and replace the entire text with “One person elected from among the active special groups in the Ward.
- (h) Introduce sub-section 17 (2) (h) to read “The Governor shall be the Patron of the Fund and shall be represented by the Sub-County Administrator in the respective Sub-County”.

6. Amendment of Section 18 of Act No. 2 of 2014

- (a) In Sub-section 18 (d) delete the words “the Bursary Forms” and replace them with the words “Forms for Loans and Grants of Youth and Women Fund”.
- (b) In Sub-section 18 (e) delete the word “Bursary” and replace with “the Youth and Women Fund”.

7. Amendment of Section 20 of Act No. 2 of 2014

- (a) In sub-section 20 (e) delete the entire text.
