THE TURKANA COUNTY FINANCE (AMENDMENT) ACT, 2020

Date of Commencement: 19th June, 2020

AN ACT of the County Assembly of Turkana to amend the Turkana County Finance Act, 2019, to re-enact the legislation relating to various County taxes, fees and charges for services and for other revenue raising measures by the county government and for connected purposes

ENACTED by the County assembly of Turkana as follows—

Citation and Commencement

1. This Act may be cited as the Turkana County Finance (Amendment) Act, 2020 and shall come into operation upon publication in *the Kenya Gazette*.

Amendment of Part II A of the First Schedule

2. The Principal Act is amended in Part II A of the First Schedule by reducing the charges for stock auction, holding ground per day and slaughter House Operations fees by fifty per cent

Substitution of Part II D of the First Schedule

3. The Turkana County Finance Act, 2020 (Principal Act) is amended in the First Schedule by deleting PART II D and substituting therefor—

Amendment of Part III of the First Schedule

4. The Principal Act is amended in Part III of the First Schedule by reducing the charges for Water transport cess and water drilling fees by fifty percent.

Amendment of Part IV of the First Schedule

5. The Principal Act is amended in Part IV of the First Schedule by waiving the fees for medical examination, inspection of premises, Public Health school inspection reports and Food and Hygiene Licenses.

Amendment of Part V of the First Schedule

6. The Principal Act is amended in Part V of the First Schedule by waiving the Application/Approval fees for registration of educational institutions.

Amendment of Part VII of the First Schedule

7. The Principal Act is amended in Part VII of the First Schedule by reducing the charges for laying of cable along road reserve from KSh. 1000 to KSh. 150

Amendment of Part VIII of the First Schedule

8. The Principal Act is amended in Part VIII of the First Schedule by Waiving the Liquor Licensing Fees, Penalty for Offloading charged in the markets and fees for impounded goods at the market.

Amendment of the Second Schedule

9. The Principal Act is amended in the Second Schedule by waiving fees for Single Business Permits for Salons, Barber Shops/Kinyozi, Hotels selling food stuff (except for those offering accommodation facilities), Bars and Night Clubs, Gymnasium and Private educational institutions such as private schools, colleges and polytechnics.
